7. Llythyr gan Aelod o'r cyhoedd ar gofeb i weithwyr y chwareli Llechi a gollodd eu bywydau

Trafodwyd llythyr a oedd wedi ei dderbyn yn gofyn i'r Cyngor Tref ystyried gosod plac ar lechen Pistyll Diffwys i gofio am y gweithwyr a gollodd eu bywydau yn chwareli'r ardal,

gan enwi pawb a fu farw a chynnwys englyn gan Gwyn Thomas arni. Ar ôl trafodaeth, a nododd faint mor anodd y byddai cael enw pawb a chaniatâd i'w cynnwys, gan na fyddai rhai teuluoedd, efallai, eisiau i enw eu hanwyliaid fod ar y garreg, cynigiodd Y Cynghorydd David Meirion Jones y bod y plac yn dweud 'Er cof am fywydau pawb a fu farw o ganlyniad i'w gwaith yn y chwareli hyn'. Gwnaeth Y Cynghorydd Geoffrey Jones welliant, gan ddweud y dylid enwi'r chwareli ac eiliodd Y Cynghorydd Peter Jones hynny. Cytunodd pawb gyda hynny. Dywedodd y Clercod y buasent yn gwneud ymholiadau o ran cael caniatâd i ddefnyddio englyn Gwyn Thomas.

Letter from a member of the public regarding a memorial plaque to mine workers who lost their lives in the slate mines

The letter was discussed, asking the Town Council to consider putting a plaque on the slate of the Fountain in Diffwys to commemorate the workers who lost their lives in the area's slate mines, naming each one and including an englyn by Gwyn Thomas. After discussion, which noted how much time and research it would take to ensure all names were correct and to get permission from all the families, some of whom who may not want the names of their loved ones on a plaque, Councillor David Meirion Jones proposed the words should be 'Er cof am fywydau pawb a fu farw o ganlyniad i'w gwaith yn y chwareli hyn' and Councillor Morwenna Pugh seconded. Councillor Geoffrey Jones proposed an amendment, that the quarries should be named on the plaque, and Councillor Peter Jones seconded. All agreed with this. The Clerks said they would make enquiries with regard to using the englyn by Gwyn Thomas.
