1. Derbyn Ymddiheuriadau / Receive Apologies

3. Cyfranogiad y Cyhoedd / Public Participation

Nid oedd unrhyw aelodau o'r cyhoedd yn bresennol yn ystod y cyfarfod.

No members of the public were present during the meeting.

4. Cofnodion/Minutes

Nododd y Cyngorydd Mark Thomas nid o gynigiodd 2 awr o waith yn y Berllan ar eitem 13. Cynigiodd y Cyngorydd David Meirion Jones ac eiliodd y Cyngorydd Geoffrey Jones fod y cofnodion yn gywir ar ôl gwneud y cywiriad.

The Councillor Mark Thomas noted that on item 13, he was not the one who offered 2 hours at the local Orchard. The Councillor David Meirion Jones offered that the minutes were correct after these amendments, the Councillor Geoffrey Jones seconded.

5. Caeau Chwarae / Playgrounds

Trafodwyd y dylai'r clerod gysylltu â Gwelliannau Ffestiniog i ofyn pwy sy'n gyfrifol am gynnal a chadw'r ardal o amgylch y lein zip yng Nghae Bryn Coed. Os yw'n cael ei benderfynu mai Cyngor y Dref sy'n gyfrifol, dylai'r clerod drefnu i'r ardal gael ei thacluso. Oherwydd dirywiad parhaus y wal yng Nghae Manod, trafodwyd y dylai'r clerod basio manylion cyswllt y Cyngorydd Mark Thomas ymlaen at gymdogion y parc i drafod y camau nesaf. Roedd cynnig gan y Cyngorydd David Meirion Jones, y dylai'r clerod drefnu

i'r metel yn y Parc Sglefrio gael ei gasglu. Dylai'r clercod egluro i'r person sy'n casglu'r metel y bydd angen iddo gadw'r tir yn daclus ac yn ddiogel yn ystod y broses. Eiliwyd y cynnig hwn gan y Cynghorydd Geoffrey Jones.

It was discussed that the clerks are to contact Gwellianau Ffestiniog to clarify who is responsible for the maintenance of the area surrounding the zip line in Cae Bryn Coed. If it is determined that the responsibility lies with the Town Council, the clerks are to organize the tidying of the area. Due to the ongoing deterioration of the wall in Cae Manod, it was discussed that the clerks are to pass on Councillor Mark Thomas's contact details to the park's neighbours to discuss the next steps. A proposal was made by Councillor David Meirion Jones, that the clerks arrange for the metal at the Skate Park to be collected. The clerks are to inform the person collecting the metal to ensure that the ground is kept tidy and safe during the process. This proposal was seconded by Councillor Geoffrey Jones.

6. Llwybrau Cerdded / Footpaths

Cytunodd y Cyngor fod y Clercod i gysylltu gyda Chyngor Gwynedd yn llun ar gamfa sydd wedi torri ar lwybr 25.

The council agreed that the Clerks are to arrange the maintenance of the Stile on footpath 25 with Gwynedd Council.

7. Rhestr Waith y Swyddog Cynnal a Chadw / Maintenance Officer's Work Schedule

Nododd y Cynghorydd Mark Thomas fod y twll yn y Berllan yn peri risg iechyd a diogelwch ac y byddai angen delio â hyn cyn gynted â phosibl. - y clercod i gysylltu gyda Gwyn Thomas. Gofynnodd y Cynghorydd Mark Thomas i'r clercod ofyn i'r garddwr roi gwybod iddo pryd fydd yn ymweld ar Berllan nesaf, er mwyn iddo allu ei gyfarfod yno. Adroddodd y Cynghorydd Peter Jones i'r cyngor y byddai angen selio'r manhol yn y parc gan fod plant wedi bod yn ei godi, gan greu perygl diogelwch posibl. - clercod i gysylltu gyda Gwyn Thomas.

The Councillor noted that the hole in the orchard posed a health and safety risk and would need to be addressed as soon as possible. The Councillor requested that the clerks ask the gardener to inform him of the next visit to the orchard, so that he can accompany him. The Councillor informed the council that the manhole at the park would need to be sealed, as children have been lifting it up, creating a potential safety hazard.

8. Cronfa'r amgylchedd a bioamrywiaeth / Environment and Biodiversity Grant

Adroddodd y Cynghorydd Mark Thomas ei fod wedi drafftio syniadau ar gyfer yr Ardd Goed ac yn mynegi ei ddymuniad i'w cyflwyno i'r swyddog grantiau. Eglurodd y Dirprwy Glerc y byddai angen cyflwyno'r grant yn enw Cyngor y Dref. Nid oedd gwrthwynebiad, a chytunodd y Cyngor.

Councillor Mark Thomas reported that he had drafted ideas for the Orchard and expressed his desire to present them to the grant officer. The Deputy Clerk explained that the grant would need to be submitted in the name of the Town Council. There was no opposition, and the Council agreed.

9. Adolygu'r wybodaeth a gasglwyd gan y Dirprwy Glerc ynghylch y goeden geirios goffa Cae Manod. Review of information gathered by the Deputy Clerk regarding the memorial Cherry Tree for Manod Park.

Cynigiodd y Cynghorydd Geoffrey Jones y dylai Cyngor y Dref dderbyn y cais i blannu coeden goffa. Eiliwyd hyn gan y Cynghorydd Troy Mclean. Gwnaeth y Cynghorydd David welliant bod cynnal a chadw'r goeden yn y dyfodol yn gyfrifoldeb y rhai sy'n ei phlannu.

It was proposed by Councillor Geoffrey Jones that the Town Council accept the request to plant a memorial tree. This was seconded by Councillor Troy Mclean. An amendment was made by Councillor David that the future maintenance of the tree would be the responsibility of those planting it.

10. Diweddariad ar gais Cyngor Tref i Gyngor Gwynedd am finiau halen ychwanegol / Update on Ffestiniog Town Council's request for additional salt bins.

Cynigiodd y Cynghorydd Peter Jones brynu bin halen ar gyfer 1 Tabernacl Terrace a 1 Mount Pleasant, a eiliwyd gan y Cynghorydd David Meirion. Gofynnodd y Cyngor i'r clerod gysylltu â Chyngor Gwynedd i ofyn am ail-ddod ystyriaeth i ganiatáu i Gyngor Tref Ffestiniog brynu bin halen ar gyfer Baltic Road. Gofynnodd y Cyngor i'r clerod gysylltu â'r Cynghorydd Sir Elfed ap Elwyn ar gyfer Bowydd a Rhiw i ofyn am ganllaw ar Baltic Road i helpu cerddwyr yn ystod y misoedd oer.

Councillor Peter Jones proposed the purchase of a salt bin for 1 Tabernacl Terrace and 1 Mount Pleasant, which was seconded by Councillor David Meirion. The Council asked the Clerks to reach out to Cyngor Gwynedd to request reconsideration of allowing the Town Council to purchase a salt bin for Baltic Road. The Council requested that the clerks contact County Councillor Elfed ap Elwyn for Bowydd and Rhiw to request a handrail on Baltic Road to assist pedestrians during the colder months.

11. Diweddariad ar y MUGA / Update on the MUGA

Adroddodd y Dirprwy Glerc ei bod yn dal i aros am ymateb gan y swyddog grant yn ymwneud â'r cais. Bydd hi'n hysbysu pawb os bydd Cyngor y Dref yn llwyddo yn eu cais. The Deputy Clerk reported that she was still waiting for a response from the grant officer regarding the application. She will inform everyone if the Town Council is successful in their application.

12. Cof golofn Rhiw a Chof golofn Llan/ Rhiw and Llan Memorial

Gofynnodd y Cynghorydd Mark Thomas i Gyngor y Dref a fyddent yn ystyried caniatáu i'r cadetiaid fyddin blannu mewn casgenni o amgylch y cof golofnau, gyda'r cyngor yn ariannu'r planhigion ar gasgenni. The Councillor asked the Town Council if they would consider allowing the army cadets to plant in barrels surrounding the memorials, with the council funding plants and containers.

13. Goleuadau Nadolig / Christmas Lights

Eglurodd y Dirprwy Glerc i'r Cyngor ei bod wedi gofyn am ddeliad goleuadau a storir yn Nolgellau i'r siambr. Gofynnodd y Cyngor i'r clerod drefnu cyfarfod gyda'r Ynghenydd Goleuadau Uwch i drafod y goleuadau yn bersonol. Cynigiodd y Cynghorydd Peter fynd i'r cyfleuster storio yn Blaenau i asesu gweddill goleuadau Nadolig y Cyngor, a eiliwyd hyn gan y Cynghorydd Troy Mclean.

The Deputy Clerk explained to the Council that she had requested the delivery of lights stored at Dolgellau to the chamber. The Council asked the clerks to arrange a meeting with the Senior Lighting Engineer to discuss the lights personally. Councillor Peter offered to visit the storage facility in Blaenau to assess the rest of the Council's Christmas lights, which was seconded by Councillor Troy Mclean.

14. Ystyried Dyfynbris gan GL Jones – Siglen Nyth Aderyn / Discuss the quotes supplied by GL Jones - Birds Nest Swing

Gofynnodd y Cyngor i'r clerod gysylltu â'r swyddog cynnal a chadw i trwsio y wyneb o dan y siglen nyth, ac i gysylltu â GL Jones i drwsio'r siglen.

The Councillor instructed the clerks to contact the maintenance officer to patch up the damaged surface underneath the bird's nest swing and to reach out to GL Jones to fix the swing.
