1. Derbyn Ymddiheuriadau / Receive Apologies

- **Derbyniwyd ymddiheuriadau am absenoldeb gan y Cynghorydd Troy Maclean.**

- Councillor Mark Thomas reported that he had received a complaint from a member of the public regarding the condition of the pavement outside the Gloddfa Shop and the stairs leading down from Ty Isallt to the train station. He requested that the clerks contact Gwynedd Council to arrange for the area to be cleared.

- **Cynigiodd y Cynghorydd David Meirion Jones dderbyn y cofnodion, a eiliwyd gan y Cynghorydd Gareth Glyn Davies a chytunodd pawb.**
- Councillor David Meirion Jones proposed acceptance of the minutes, seconded by Councillor Gareth Glyn Davies and all present agreed.

Playgrounds Monthly inspection for October 2024 - Receive a summary of Helen Jones' monthly inspections of the playgrounds.

- **Adroddodd y Dirprwy Glerc i'r cyngor fod yr wybodaeth ar goll o'r adroddiad wedi'i drafod, ac nad oedd unrhyw beth i'w adrodd gan yr arolygwr chwaraeon yn y rhannau hynny.**

Adroddodd y Cynghorydd Mark Thomas ei fod wedi methu â derbyn gohebiaeth gan y person a oedd if od i glirio'r parc sglefrio, fel y penderfynwyd gan y cyngor. Cynigiodd bod y Cyngor yn penodi cwmni arall i wneud y gwaith. Eiliodd Y Cynghorydd David Meirion Jones, a chytunodd pawb. Adroddodd hefyd ei fod wedi siarad â Swyddog Grantiau, a oedd yn son y gallai fod grantiau ychwanegol ar gael ar gyfer y Berllan, a gofynnodd i'r clerod ymchwilio i hyn ymhellach.

- The Deputy Clerk reported to the council that the missing information from the report had been discussed, and there was nothing to report from the playground inspector in those sections.

Councillor Mark Thomas reported that he had not received correspondence from the individual who was supposed to clear the skate park, as agreed by the council. He proposed that the Council appoint another company to carry out the work. Councillor David Meirion Jones seconded and everyone agreed. He also reported that he had spoken to a Grant Officer, who mentioned that there could be additional grants available for the Orchard, and requested that the clerks investigate this further.

The Chairman, Morwenna Pugh, reported that the entrance gate to the Skate Park site had been removed from its hinges approximately two weeks ago. The Clerk also reported that the Council Maintenance Officer had visited the site to address the issue.

The Council accepted the Playground report.

- **Proposal by Councillor Mark Thomas to accept the report and to write to Gwynedd Council to inform them that the Town Council is re-reporting issues previously raised without receiving any updates from the County Council on whether the work has been completed. Seconded by Councillor Mark Lloyd Griffiths and all agreed.**

- **Derbyniodd y Cyngor ddiweddariad llafar gan y Cadeirydd Morwenna Pugh a'r Cynghorydd Peter Jones, a ymwelodd yn ddiweddar â'r depo sy'n storio goleuadau Nadolig y dref. Adroddwyd nad oedd llawer o'r goleuadau bellach yn gweithio. Roedd y goleuadau presennol yn Siambr y Cyngor wedi'u trefnu i'w casglu gan Gyngor Gwynedd i'w harddangos ar gyfer Nadolig 2024. Adroddwyd hefyd fod Cyngor Gwynedd angen caniatâd y Cyngor Tref i waredu unrhyw oleuadau anaddas, heb dâl. Cytunodd y Cyngor.**

- **Mynegodd y Cynghorydd Dafydd Dafis ei siom am ddiffyg goleuadau Nadolig yn ward Tanygrisiau. Eglurodd y Cadeirydd Morwenna Pugh fod y peiriannydd goleuo wedi nodi mai dim ond rhai goleuadau stryd oedd yn addas ar gyfer goleuadau'r Cyngor Tref, ac roedd gan wardiau eraill yr un broblem.**
- **Cynigiodd y Cynghorydd Geoffrey Jones y dylai'r clerod ofyn i'r peiriannydd goleuo am ba oleuadau stryd yn y wardiau y gellid gosod goleuadau'r Cyngor Tref arnynt. Eiliwyd gan y Cynghorydd Mark Thomas a chytunodd pawb.**
- **Gofynnodd y Cynghorydd Mark Thomas i'r Cyngor archebu coed Nadolig ar gyfer Canol y Dref a Llan Ffestiniog cyn gynted â phosibl.**

- The Council received a verbal update from Chair Morwenna Pugh and Councillor Peter Jones, who recently visited the depot housing the town's Christmas lights. They reported that many of the lights were no longer functional. The current lights in the Council chambers were scheduled to be collected by Gwynedd Council to be displayed for Christmas 2024. It was also reported that Gwynedd Council required the Town Council's permission to dispose of any unusable lights, free of charge. The Council agreed.
- Councillor Dafydd Dafis expressed disappointment over the lack of festive lighting in the Tanygrisiau ward. Chair Morwenna Pugh explained that the lighting engineer had noted only certain streetlights were suitable for the Town Council's lights, and other wards faced similar limitations.
- Councillor Geoffrey Jones proposed that the clerks ask the lighting engineer to identify which streetlights in the wards could accommodate the Town Council's lights. This was seconded by Councillor Mark Thomas and all agreed.
- Councillor Mark Thomas requested that the Council reserve Christmas trees for the Town Centre and Llan Ffestiniog as early as possible.
